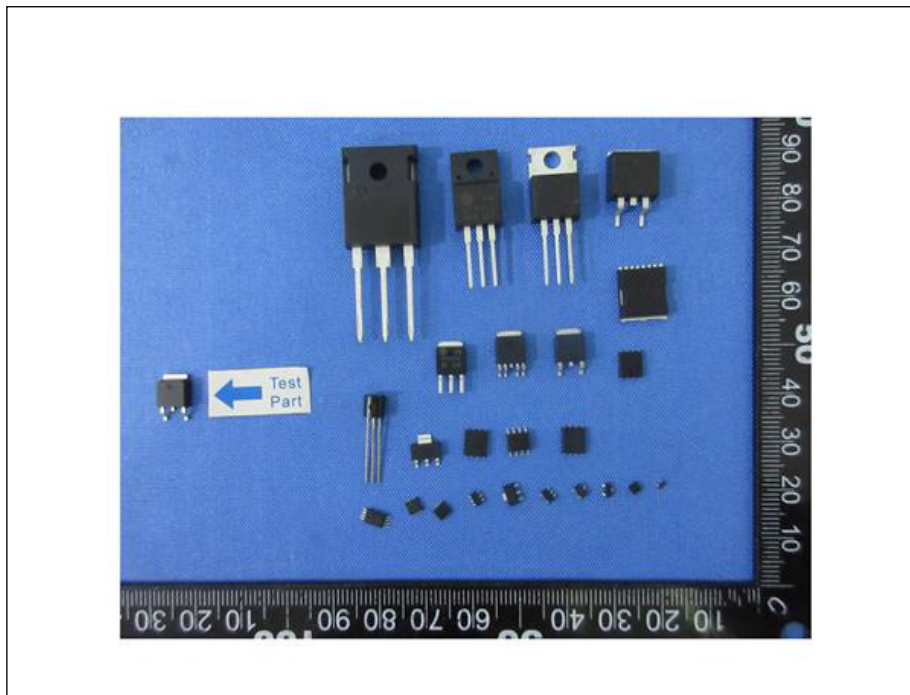

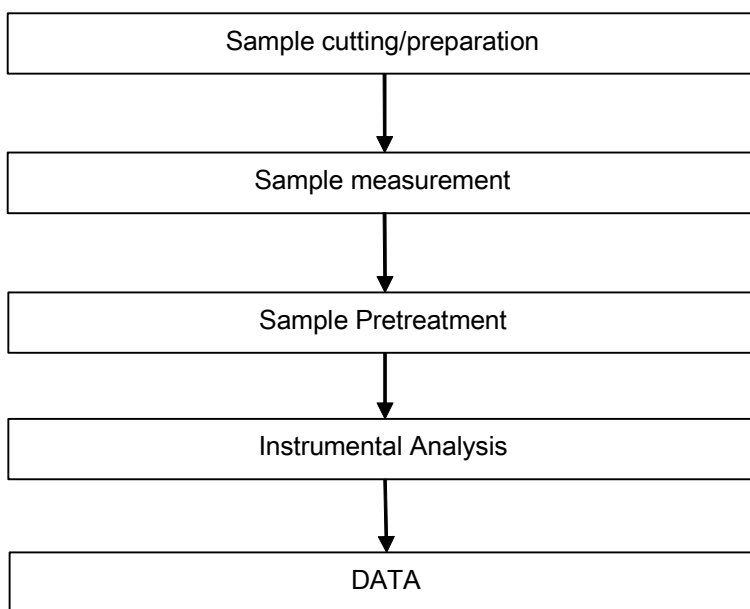

### SVHC Testing Flow Chart



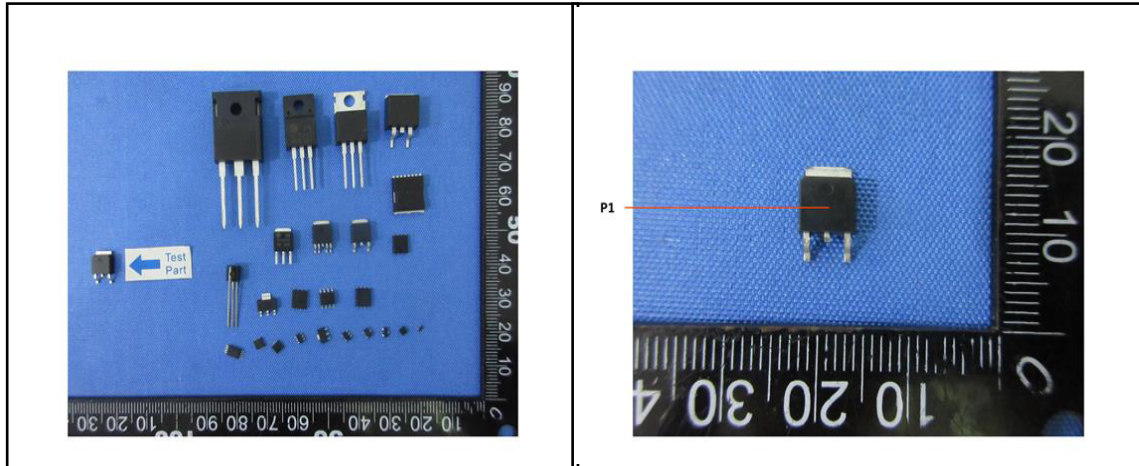
